## Dear Donation Seekers:

**We ask that you look over the following criteria before submitting your request.**

1. Requests by phone are not accepted. Donation requests must be dropped off at the Customer Service Counter at the Cherry Creek Store. Unfortunately we cannot meet with every organization that stops by to drop off an application. We will contact you directly if we have questions.
2. Your organization or event must be in the Denver Metro area
3. The recipient must be a 501-C (3) nonprofit organization. A copy of the 501-C (3) letter from the IRS must accompany the application. This letter comes from the Treasury Department and is different from the state tax-exempt form.
4. The application must be received at least 45 days before the “event date” or date of “pick up” date in order to be considered. All applications are reviewed on a first-come-first serve basis. Because the donations budget is limited, early submission of your application is recommended.
5. Whole Foods Market has specific guidelines for the organizations we are able to support with donations. In addition to being a non-profit, you must fall into one of these categories:
  - Environmental Preservation
  - Preventative Health Care
  - Hunger Relief
  - Organic Farming / Sustainable Food Resources
  - Education on any of the aboveBecause Whole Foods Market believes in being an active community member, requests from other civic and charitable groups will be considered if the organization is in the immediate vicinity of a store location, meets our core values, and funding is available.
6. We do not donate to individuals, individuals seeking pledges, or multiple requests from the same organization or organizations and / or causes. **Each approved organization is restricted to one donation per year from any and all Whole Foods Market stores.**
7. Past support of an organization or event is not a guarantee of future support. *An organization may only receive 1(one) donation per year.* Please do not apply for additional Donations.
8. Although we would like to support every worthwhile cause, due to the volume of applications, it is not possible for Whole Foods Market to fulfill every request. We will make an attempt to respond by email or postcard to all of those who have not been granted their requests.
